ORANGE COUNTY RESOLUTION NO. 92-M-66

A RESOLUTION CREATING THE NORTH INTERNATIONAL DRIVE IMPROVEMENT MUNICIPAL SERVICE TAXING UNIT; AUTHORIZING SUCH TAXING UNIT TO ANNUALLY LEVY AD VALOREM TAXES; AUTHORIZING CERTAIN EXPENDITURES; ABOLISHING SUCH TAXING UNIT ON OCTOBER 1, 1998; PROVIDING FOR SEVERABILITY; PROVIDING FOR THE SUNSET OF THIS RESOLUTION; AND PROVIDING AN EFFECTIVE DATE.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

SECTION 1. FINDINGS. It is hereby ascertained, determined and declared that:

(A) Pursuant to Article VIII, Section 1 of the Florida Constitution, and Sections 125.01 and 125.66, Florida Statutes, the Board of County Commissioners (the "Board") of Orange County, Florida (the "County"), has all powers of local self-government to perform county and municipal functions and to render services in a manner not inconsistent with general law and such power may be exercised by the enactment of county ordinances and resolutions.

(B) Section 125.01(1)(q), Florida Statutes, provides specific legislative authorization for counties to establish a municipal service taxing unit for any part or all of the unincorporated areas within its boundaries, or within the municipal boundaries of an incorporated area upon consent of the governing body of such municipality, within which may be provided essential facilities and services. (C) The purpose of this Resolution is to create the North International Drive Improvement Municipal Service Taxing Unit (the "Taxing Unit") to fund the activities described in Section 4 hereof.

SECTION 2. CREATION. The North International Drive Improvement Municipal Service Taxing Unit is hereby created pursuant to Section 125.01(1)(q), Florida Statutes. The Taxing Unit shall include the property described in Appendix A.

SECTION 3. AUTHORIZATION OF AD VALOREM TAXES. The Board is hereby authorized to levy ad valorem taxes upon taxable real and personal property within the Taxing Unit at rates not in excess of 0.2 mill per annum.

SECTION 4. AUTHORIZATION OF EXPENDITURES. Revenues derived from ad valorem taxes shall be used for the following purposes:

(A) developing plans and recommendations to state and local governments for physical improvements and changes in laws and regulations needed to foster tourism within the Taxing Unit by improving pedestrian walkways and streetscapes, beautifying the area, limiting excessive public and private signage, and improving and unifying all landscaping, and participating in the construction and implementation of any such plans and recommendations;

(B) developing plans and recommendations to state and local government for programs and projects to alleviate traffic congestion, and participating in the construction and implementation of any such plans and recommendations;

(C) developing alternative sources of revenue to fund the activities described in this Section, including but not limited to special assessments, sales taxes, admissions taxes, food and beverage taxes, and ad valorem taxes that are not within the millage limitations imposed upon the City or County;

(E) reimbursing the County and the City of Orlando (the "City") for amounts advanced to fund the activities described in this Section; and

(F) funding other facilities and services within the Taxing Unit to benefit the residents and taxpayers of the Taxing Unit.

The Board is specifically authorized to enter into an agreement with the International Drive Master Transit and Improvement District for performance of the activities described in this Section.

SECTION 5. ABOLITION OF TAXING UNIT. The Taxing Unit is abolished on October 1, 1998.

SECTION 6. SEVERABILITY. If any clause, section or provision of this Resolution shall be declared unconstitutional or invalid for any reason or cause, the remaining portion of said Resolution shall be in full force and effect and be valid as if such invalid portion thereof had not been incorporated herein.

SECTION 7. SUNSET PROVISION. This Resolution is hereby repealed on October 1, 1998.

SECTION 8. EFFECTIVE DATE. This Resolution shall take effect upon the enactment by the City of an ordinance consenting to the inclusion of a portion of the incorporated area of the City

within the boundaries of the Taxing Unit, as required by Section 125.01(1)(q), Florida Statutes.
